

CPS 2016 Charter School Assessments

UIC / UIH Pharmacy Clean Room Suite CPS 2016 Charter School Assessments -

As part of the Chicago Public Schools 2016 Charter School Assessment Program, TAEL provided architectural, structural and MEP services to assess and rank elements of five charter school facilities ranging in size from 25,000 s.f. to 50,000 s.f. The assessment categories included site, exterior, interior, structural, mechanical, electrical, plumbing, fire protection, security and audio systems. The assessed condition of these categories ranked from 7 (new or sound condition - no work required) to 1 (life safety hazard or uninhabitable facility).

The deliverable consisted of one (1) report per facility with narrative describing and ranking the assessment categories referenced above, with supporting photo documentation and applicable code sections to any deficiency identified.

UIC / UIH Pharmacy Clean Room Suite

The University of Illinois at Chicago Office of Capital Programs selected TAEL to design and oversee the renovation of the University of Illinois Hospital Pharmacy Clean Room Suite, located in the concourse of the main hospital building. One of the main challenges of the renovation is that the balance of the facility needs to remain fully functional 24/7. The completed installation must comply with ISO 5000, as well as USP 797 and USP 800.

The functional program includes a Gowning area, an Anteroom, an Aseptic room, a Chemo room and a Walk-in Refrigerator/Freezer. The general aspects of the project include gutting the entire suite, reconfiguring the layout to optimize the functional relationship of the requirements, increasing visual communication between rooms and providing new finishes and equipment.

The project also includes a new dedicated exhaust system for the Chemo Hood, new lighting, equipment power, and receptacle power, along with new voice/data outlets, cameras and intercom. As part of the project, the existing sprinkler system will be revised and updated.
